OFSTED

Inspections in the Diocese have now started where there is no single word overall grade of effectiveness. Section 8 and Section 5 inspections have taken place. There will be no deep dives for section 5 inspections except for maths and early reading. The tone of the inspection appears to be different. Schools are being notified on a Monday, and inspections on the Tuesday and Wednesday followed by feedback on the Wednesday. There have been in some weeks 3 inspections of Diocese schools in different locations. There are <u>links to webinars on the OFSTED</u> site and the Diocese have some training planned for Governors and Directors on the 6th November 24. The government intend to introduce a school report card inspection from September 2025. The DFE will be consulting on the new system in the coming months.

New OFSTED handbook

This handbook came into force on 16 September 2024 and describes the main activities carried out during graded, ungraded and urgent inspections of maintained schools and academies in England under sections 5 and 8 of the Education Act 2005, respectively. It sets out the grade descriptors that inspectors use to make their judgements and on which they report. It applies to school inspections under the <u>education inspection framework</u> (<u>EIF</u>).

OFSTED handbook

Catholic School Inspection (CSI)

As you know, Catholic School Inspections in the Brentwood Diocese commenced in January 2023. There have been a number of changes made to the OFSTED inspection handbook. However, the CSI handbook has not moved away from worded grading and overall effectiveness. There was a long consultation by CSI and any changes require the Bishops' approval, so there will be no rush to make changes. There is one change to the CSI handbook as to who can be informed of a CSI inspection. The Headteacher can tell family and staff but it should remain confidential until the report is published. The biggest change is to compliance.

Updated Bishops' Memorandum of Understanding on the Appointment of Staff in Catholic Schools - approved September 2024

As is clear in the <u>Memorandum of Understanding</u> the updated version does not include any additional requirements to those in the 2014 version, it simply sets out the requirements in a way which reflects the organisation of Catholic schools today. This version will be available on the CES website shortly.

Nature Park East of England

This DFE initiative is "to support educational settings from EYFS up to Further Education to improve biodiversity across their school sites. This is a project the Department of Education has created, with the Natural History Museum heading up the programme. This programme links and supports the DfE Sustainability and Climate Change strategy. The hope is that all the school grounds across England, where schools create more green spaces from grey spaces, will equate to twice the size of Birmingham. Therefore, it would be great to get as many schools as possible on board with the project. There are lots of resources on the website for all ages and it gives a clear step by step guide on signing up, recording their site boundary on the wider map and then they can map any habitats on their school site. This will also give them the opportunity to plan **how they wish to improve biodiversity on their school sites.**

Curriculum and Assessment Review

The Curriculum and Assessment Review has been set up to review the national curriculum and statutory assessment system in England, including qualification pathways. It will consider children and young people's education and experiences from ages 5 to 19. Further details about the Review's aims, its terms of reference and working principles can be found <u>here</u>.

Latest Research and Resources

The Sutton Trust's says equal access to top-performing schools is crucial for enhancing social mobility.

Earlier this year the Sutton Trust published its latest research into the socioeconomic mix of pupils in the top performing comprehensive schools. The results were stark. In essence, students who are eligible for free school meals (FSM) are less likely to attend a top-performing comprehensive than their more affluent peers, even if there is one in the local area. <u>Selective-Comprehensives-2024.pdf (suttontrust.com)</u>

The Law Commission published on 8 the October aa <u>consultation paper on disabled</u> <u>children's social care law</u>, as part of a review to ensure it is fairer, simpler and more up to date.

Concerns surrounding SEND provision in mainstream schools

There has been a 25% increase in the number of pupils with education, health and care plans (EHCP) receiving support in specialist resource provisions (SRP) or SEND units in mainstream schools over the past six years. This is according to a <u>Tes analysis of DfE data</u>.

With the increasing role of SEND units and SRP the government is being urged by key sector voices to investigate how mainstream schools are using additional provision to support pupils with special educational needs and disabilities (SEND) amid concerns about a lack of oversight and guidance.

NGA's <u>Annual Governance Survey</u> also revealed an increase in SEND demands, with the proportion of boards identifying support for children with special educational needs as a top challenge has risen dramatically to 37%, from 25% in 2022.

New Edurio report: High quality, inclusive education

A recent **Edurio report**, focusing on education quality and inclusion, highlights a decline in pupil happiness and an increase in staff violence in schools. Pupil levels of interest in learning and overall happiness have significantly worsened, with only 47% of pupils feeling very or quite happy at school. Additionally, the report reveals a decline in respect from pupils towards staff, with a record-high proportion of staff **experiencing violence**.

While the report highlighted areas of concern, it also identified positive trends. Pupils are more engaged in reading for studies and extracurricular activities, and staff perceive increased support from the school for lesson planning, marking, and assessment.

Survey reveals impact of cyber security

Just over one third (34%) of schools and colleges in England have experienced a cyber incident during the last academic year, with 20% not recovering immediately and 4%

taking more than one half term. This is *according to a new poll by Ofqual who* are highlighting the risks associated with poor cyber security.

Other findings revealed that cyber incidents in schools were mostly due to phishing attacks and security breaches which resulted in lost coursework and missing staff resources. In addition, one in three teachers reported not having had cyber security training this year
