Governor News - November 2024

Welcome to the monthly newsletter for governors. This is monthly summary to help governors keep up to date with key themes of national education policy, the local Diocesan context, research and good practice.

National Audit Office SEND report: Special education system is 'failing'.

The special educational needs (SEN) system is financially unsustainable unless reformed according to findings published this week by the National Audit Office (NAO). The <u>report</u> assessing the effectiveness of support for children and young people with SEN in England highlights significant financial pressures, with increased high-needs funding not translating into better outcomes.

OFSTED

Inspections in the Diocese have now started where there is no single word overall grade of effectiveness. Section 8 and Section 5 inspections have taken place. There will be no deep dives for section 5 inspections except for maths and early reading. The tone of the inspection appears to be different. Schools are being notified on a Monday, and inspections on the Tuesday and Wednesday followed by feedback on the Wednesday. There have been in some weeks 3 inspections of Diocese schools in different locations. There are <u>links to webinars on the OFSTED</u> site and the Diocese have some training planned for Governors and Directors on the 6th November 24. The government intend to introduce a school report card inspection from September 2025. The DFE will be consulting on the new system in the coming months.

NGA has published its landmark report The Mature MAT Model, reflecting on the evolution of the multi-academy trust model to the present day, where more schools are part of a trust than not, and where a clear majority of pupils are educated within one.

The DFE has announced £15 million to fund a further specialist attendance mentor programme where persistently absent pupils will be supported over a 12 to 20 week period and will have a specific plan to help them.

The Department for Education academy conversion - will end its grant scheme for schools choosing to become an academy at the end of this year and has "no plans" to continue to run its trust capacity and trust establishment and growth funds. Trusts



waiting to hear about capacity and growth funding bids for this summer's funding round of both funds have also been told no cash will be handed out.

It comes as the new Labour government seeks to rationalise the dual school system in England.

How will the Employment Rights Bill impact schools?

The government published its plan for workers' rights this week, with the business secretary describing it as "the biggest upgrade in employment rights for a generation". Consultations on the Employment Rights Bill are expected this year, but the government said the measures will not come into force earlier than 2026.

The education secretary, Bridget Phillipson, confirmed this week that the bill will kickstart the restoration of the School Support Staff Negotiating Body (SSSNB). <u>Employment Rights Bill explained</u>

Induction - Being an Effective Governor in a Catholic School
