DfE announcement, single-word judgements

The Department for Education announced on 2nd September that they are intending to introduce a School Report Card inspection system from September 2025. The details of this, and the necessary legislation to bring it about, will be worked out over the coming months. In the interim year, for state-funded schools, they have instructed Ofsted to scrap the use of the single-word overall effectiveness judgement grade. We understand that due to the current constraints of legislation, the overall effectiveness single-word judgement grade will remain for all other kinds of setting which Ofsted inspects, including sixth form colleges, non-maintained special schools, and non-association independent schools. Single-word judgement grades will continue to be given for the sub-categories until the current education inspection framework (EIF) is superseded in September 2025. In addition, schools that would have previously been graded as inadequate, will still be labelled either as 'special measures' or 'requiring significant improvement', with all the attendant consequences of such an outcome.

DFE - Schools Music Development Plan

All schools should have a <u>music development plan</u>, as set out in the <u>national plan for music education</u>.

The DFE are asking schools to publish a summary of their music development plan on their website before the start of the 2024 to 2025 academic year. Schools should then update the summary before the start of each new academic year.

Publishing a summary will help schools to:

- raise awareness of their music development plan
- promote the school music offer to parents and prospective parents
- give greater opportunity for schools and music hubs to work together

School music development plan: summary template

Safeguarding: Ensure compliance with updated guidance – Keeping Children Safe in Education (KCSiE) has been published for 1 September 2024

All staff to receive updated training which includes the new KCSiE guidance

- Child Protection/Safeguarding policy complies with the updated version of KCSiE ensure the governing board approves the revised policy
- All Governors/Trustees have read the updated version of KCSiE
- All Governors/Trustees to have received appropriate safeguarding training

Induction - Being an Effective Governor in a Catholic School
