Catholic School Inspection-updates

CSI inspections continue from w/b 20th January 2025 - It is really important that schools ensure they refer to the most up to date Inspection Handbook and Comparative Grade Descriptors- January 2025 v3.2. There is a helpful change log which lists the changes made in the updated handbook – a shortened version of which is attached above; the original can be found on the website.

The Children's Wellbeing and Schools Bill

You will have seen reports in the news about the new Children's Wellbeing and Schools Bill. The DfE has issued some useful information about the contents of the bill on its Education Hub, and you can find that information by following the link below:

The CES will provide further guidance to dioceses as the provisions of the bill are worked through, but in the meantime, the DfE want us to reassure school leaders that no immediate action is necessary and there will be time for schools to prepare for any changes that are required, particularly in relation to teacher pay and conditions.

Academies

- Confederation of School Trusts 'very concerned' about proposals around academy pay flexibility Two government bills should be amended to ensure school flexibility over pay, the Confederation of School Trusts (CST) has said.
- Concerns that academy reforms would allow more <u>schools that select based on faith</u>. Humanists fear the government's academy reforms will pave the way for new Catholic schools which select all their pupils based on faith. [Schools Week]
- CEOs of the largest trusts 'escape scrutiny' over pay under new pay checks [Schools Week] The government's new CEO pay crackdown has allowed the biggest chains to escape scrutiny as the method used to identify "outliers" appears to be loaded against smaller trusts.

Schools Week analysis of Department for Education data used to name and shame 37 leaders over high wages reveals it held some "to a different standard" based on size. We can also reveal that bungling officials used the wrong figures in their analysis for the country's best-paid CEO – Harris Federation's Sir Dan Moynihan. The figure used was £150,000 off his actual salary, fuelling more uncertainty over officials' workings.
